SUBJECT: SUMMARY OF THE SEPTEMBER 1, 1999, MEETING BETWEEN THE
NUCLEAR REGULATORY COMMISSION AND PRIVATE FUEL
STORAGE, LIMITED LIABILITY CORPORATION

On September 1, 1999, a meeting was held among representatives from the Nuclear Regulatory Commission (NRC), Bureau of Indian Affairs (BIA), Bureau of Land Management (BLM), and Private Fuel Storage, Limited Liability Corporation (PFS) to discuss the August 19, 1999, request for additional information (RAI). The RAI is for the environmental impact statement (EIS) being prepared for the proposed Private Fuel Storage Facility on the reservation of the Skull Valley Band of Goshute Indians. Also attending the meeting were representatives of the Science Applications International Corporation (SAIC), BIA's technical support; Oak Ridge National Laboratory (ORNL); the State of Utah's Attorney General Office; the Southern Utah Wilderness Alliance; Ohngo Gaudadeh Devia; and Utah Congressman James V. Hansen's office. The attendance list is attached. This meeting was noticed on August 19, 1999.

During the course of the meeting, PFS requested clarification on approximately 15 of the 51 questions included in the RAI. The cooperating agencies along with ORNL provided the clarification requested by PFS. No other issues were discussed during the meeting, and no regulatory decisions were requested or made.
