SUBJECT: SUMMARY OF MEETING WITH THE PRIVATE FUEL STORAGE,
LIMITED LIABILITY CORPORATION

On May 19, 1999, staff from the U.S. Nuclear Regulatory Commission's (NRC's) Spent Fuel Project Office (SFPO) and Office of the General Counsel met with representatives of the Private Fuel Storage, Limited Liability Corporation (PFS). Also attending the meeting were representatives of Shaw, Pittman, Potts and Trowbridge and the Ibx Group. The purpose of the meeting was to provide an opportunity for the Chairman of the Board of PFS to meet with the new SFPO Director. The meeting included a general discussion of the safety and environmental reviews of the PFS application that are currently underway. Attachment 1 is a list of meeting attendees.
