Performance Data

Clinton Power Station incurred no reportable fitness for duty events during the July – December 31, 2000 reporting period. The random testing rate was completed in accordance with 10CFR 26.24 (a)(2).

MANAGEMENT ACTIONS

During the July – December 31, 2000 six-month reporting period, at least 85% of the specimens which were determined to be presumptively positive as a result of preliminary on site screening tests for marijuana and cocaine, were subsequently reported as positive by the HHS certified laboratory as the result of GC/MS confirmatory testing.

* Clinton Power Station tests all site employees with and without unescorted access privileges. The numbers given reflect the numbers of all individuals in the random selection program.

** Numbers given reflect testing of those individuals placed on a monitoring program per the Medical Review Officer's (MRO) recommendation due to background information and personal interviews by the MRO. Also included in these numbers are those retests required due to low specific gravity or low creatinine.
