The purpose of this letter is to submit the amendment to the Private Fuel Storage Facility (PFSF) License Application (LA) that incorporates the effects of recent responses to NRC requests for additional information (RAI). In addition to the RAI responses, the amendment also reflects the probabilistic seismic hazard analysis methodology for the PFSF, as well as minor corrections to the licensing documents. Although most of the license amendment changes involve revisions to the Safety Analysis Report (SAR) and Environmental Report (ER), the Emergency Plan (EP) and LA have also been revised.



The NRC submitted its second round RAI on the SAR and EP in Reference 1, and a RAI on the ER in Reference 2. PFS responded to the RAI on the SAR and EP in Reference 3, and to the RAI on the ER in Reference 4. Reference 3 also submitted the remaining responses to the NRC's first round RAI transmitted by Reference 5. Reference 6 discusses the probabilistic seismic hazard analysis methodology that PFS is planning to use. The amendments to the PFSF licensing documents incorporate the effects of References 3, 4 and 6.
