License Amendment Request Nos. 280 and 284**

FirstEnergy Nuclear Operating Company (FENOC) submitted License Amendment Request (LAR) Nos. 280 and 151 for Beaver Valley Power Station (BVPS) Unit Nos. 1 and 2 on May 12, 2000. This request proposed to modify information on design basis accident radiological doses at each unit. This request involved changes to the UFSAR description for numerous design basis accidents, including the Major Secondary System Pipe Rupture (or Main Steam Line Break, MSLB) event at BVPS Unit No. 1.

Subsequently, FENOC submitted License Amendment Request No. 284 for BVPS Unit No. 1 on July 21, 2000. This request proposed to reduce the Reactor Coolant System specific activity limit in the Technical Specifications. In support of this Technical Specification change request, additional changes were proposed to BVPS Unit No. 1 UFSAR description for the MSLB design basis accident. In LAR 284, the proposed changes to the BVPS Unit No. 1 UFSAR were superimposed upon the UFSAR changes previously submitted by LAR 280. Thus, LAR 284 supersedes LAR 280 only for the analysis, justification, and the proposed UFSAR changes associated with the BVPS Unit 1 MSLB design basis accident. FENOC requests that the BVPS Unit 1 MSLB design basis accident be reviewed as part of LAR 284. There have not been any other changes to the proposed modifications requested by LAR 280 for the remaining BVPS Unit Nos. 1 and Unit 2 design basis accidents.
