

The purpose of this modification is to provide incremental funding in the amount of \$38,000.00 to provide for continued performance of the effort under the contract. Accordingly, the contract is modified as follows:

Under Section B.3, "Consideration and Obligation -- Cost Reimbursement & Task Order Hybrid," paragraph f is deleted in its entirety and replaced with the following in lieu thereof:

"f. The amount presently obligated by the Government with respect to this contract is \$3,169,109.69 of which the sum of \$2,946,294.21 represents the estimated reimbursable costs and the amount of \$222,815.48 represents the fixed fee."
