## INSTRUCTIONS TO STUDENTS

**ACCEPTANCE:** This is to advise you that the individuals listed on Enclosure 1 have been accepted for participation in the "Sealed Source and Device Evaluation Workshop." This workshop is scheduled to be presented April 2- 6, 2001 at the Four Points Barcelo Hotel Burlington, 30 Wheeler Road, Burlington, Massachusetts 01803, Telephone: (800) 325-3535.

**COURSE:** Students will be expected to be present at the beginning of the workshop on Monday, April 2, 2001 at 8:00 a.m. to 5:00 p.m. The Workshop will end at 12:00 noon on Friday April 6, 2001. Students will be required to complete casework assignments by working together with other students after class hours.

**LODGING & TRAVEL:** You should plan to arrive on Sunday, April 1, 2001 and depart on Friday, April 6, 2001. Participants must make their own lodging and travel arrangements. Individuals should request the State or government employee rate of \$179.00 plus 9.7% per night for a single or double room.
