The purpose of this modification is to provide incremental funding which increases the contract obligated amount by \$1,200,000.00 from \$27,774,544.55 to \$28,974,544.55. Accordingly, the following section of the contract is hereby modified:

Section B.4 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUN 1991) paragraph (c) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"(c) The amount currently obligated by the Government with respect to this contract is \$28,974,544.55, of which the sum of \$28,128,814.33 represents estimated reimbursable costs, and of which \$845,730.22 represents the fixed fee.

A summary of obligations under this contract, from date of the award through this modification, is given below:

This modification obligates FY99 funds in the amount of \$1,200,000.00.

All other terms and conditions of the contract, including the ceiling amount of \$29,777,678.01, remain the same.
