

The purpose of this modification is to provide incremental funding which increases the contract obligated amount by \$803, 133.46 from \$28,974,544.55 to \$29,777,678.01. Accordingly, the following section of the contract is hereby modified:

Section B.4 CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUN 1991) paragraph (c) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

“(c) The amount currently obligated by the Government with respect to this contract is \$29,777,678.01, of which the sum of \$28,931,947.79 represents estimated reimbursable costs, and of which \$845,730.22 represents the fixed fee.

A summary of obligations under this contract, from date of the award through this modification, is given below:

This modification obligates <sup>00</sup>FY99 funds in the amount of \$803, 133.46.

All other terms and conditions of the contract, including the ceiling amount of \$29,777,678.01, remain the same.
