The purpose of this modification is to:

- (1) revise subsection B.4 CONSIDERATION AND OBLIGATION -- COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) by (a) increasing the contract ceiling to \$35,944,228; and (b) providing incremental funding which increases the contract obligated amount by \$758,866.54, from \$29,809,678.01 to \$30,568,544.55;
- (2) extend the period of performance; and
- (3) exercise the government's option of extending the term of the contract.

This modification also confirms receipt of an e-mail message from Sytel's Director of Contracting, Ms. Judy Schaefer, on December 14, 1999; in which Sytel waived the 60-day notice requirement of the exercise of this option.

Accordingly, the contract is hereby modified as follows:

1. Under subsection B.4 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUN 1991) paragraphs (a) and (c) are deleted in their entirety and the following paragraphs are substituted in lieu thereof:
 - (a) The total estimated cost to the Government for full performance of this contract is \$35,944,228, of which the sum of \$34,900,676 represents estimated reimbursable costs, and of which \$1,043,552 represents the fixed fee
 - “(c) The amount currently obligated by the Government with respect to this contract is \$30,568,544.55, of which the sum of \$29,524,992.55 represents estimated reimbursable costs, and of which \$1,043,552 represents the fixed fee.

2. Under section F.4DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 3 (MAR 1987), delete the paragraph entirely and the following paragraph is substituted in lieu thereof:

Although the Government contemplates use of the system (s) (hardware and software) for the system's life of five years from date of installation, the term of this contract is forty-eight (60) months from the effective date of the contract. (Expiration date - 04/07/2001)

3. Under clause I.5, 52.217-9 - OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 1989) the Government hereby exercises its option to extend the term of the contract for one year.
