By letter dated December 29, 2000, AmerGen Energy Company, LLC (AmerGen, the licensee) submitted an application for license amendment to extend the Technical Specification (TS) allowed outage time (AOT) from 72 hours to 14 days for the Division 1 and 2 diesel generators (DGs).

Subsequently, by letter dated January 14, 2001, AmerGen requested enforcement discretion for the Division 2 DG, due to high vibration of a bearing during the 24-hour surveillance test. AmerGen also requested exigent review of the amendment request. The U.S. Nuclear Regulatory Commission (NRC) staff granted the enforcement discretion as discussed in a letter dated January 18, 2001. In that letter, the staff stated that it would review and issue the license amendment request as promptly as possible (i.e., exigent review schedule).

Upon further review, the NRC staff has found that permanent risk informed TS changes of a magnitude such as this one should not be reviewed and approved on an exigent basis. This particular risk informed permanent TS change requires a careful review because of the risk significance. We believe that this constitutes special circumstances under which exigent review is not appropriate following issuance of enforcement discretion. Therefore, the staff will review your amendment request on a normal priority schedule instead of an exigent schedule.
