SUBJECT: ISSUANCE OF AMENDMENTS FOR CALVERT CLIFFS NUCLEAR POWER PLANT, UNIT  
NO. 1 (TAC NO. M91854) AND UNIT NO. 2 (TAC NO. M91855)

Dear Mr. Cruse:

The Commission has issued the enclosed Amendment No. 216 to Facility Operating License No. DPR-53 and Amendment No. 193 to Facility Operating License No. DPR-69 for the Calvert Cliffs Nuclear Power Plant, Unit Nos. 1 and 2, respectively. The amendments consist of changes to the Technical Specifications (TSs) in response to your application transmitted by letter dated March 15, 1995, as supplemented on June 29, 1995, May 1, 1996 and May 15, 1996.

The amendments revise the TS Section 6.0, "Administrative Controls" to be consistent with the guidance provided in the Improved Standard Technical Specifications (STS) for Combustion Engineering Plants. Additionally, the amendments (a) allow the Shift Technical Advisor to perform dual roles, (b) establishes a TS Bases Control Program, (c) provides for a reduction in the reporting requirements, and (d) provides an option for estimating occupational doses.

Your March 15, 1995, letter as supplemented on June 29, 1995, May 1, 1996 and May 15, 1996, also requested approval of quality assurance policy changes which are necessary as the result of these amendments. By letters dated March 29, 1995, and May 17, 1996, the NRC staff indicated that this portion of your request is contingent upon approval of the proposed amendments and that the results of the NRC staff's review of the proposed quality assurance policy changes would be provided shortly after the completion of the TS amendment review. Thus, action on these matters will be taken at a later date.
