MEMORANDUM AND ORDER

(General Schedule Revision)

By joint report submitted February 9, 2001, as supplemented on February 15, 2001, the parties to this proceeding provided the Licensing Board with their views on the hearing schedule impacts of the information in the NRC staff's January 23, 2001 letter to the Board. In that letter, the staff declared that because of recent and planned submissions by applicant Private Fuel Storage, L.L.C. (PFS), regarding aircraft crash/cruise missile and geotechnical issues, the staff anticipated postponing the February 28, 2001 date for issuance of the final environmental impact statement (FEIS) for the proposed PFS facility and possibly preparing a Safety Evaluation Report supplement (SSER). In the joint report, the staff acknowledged that, pending its review of the information PFS has indicated it intends to submit, it anticipates the FEIS will be delayed some five months, until July 31, 2001, and that its review of aircraft crash/cruise missile matters would not be completed until approximately April 30, 2001. Thereafter, in the February 15, 2001 supplemental report, the staff indicated it now believes it will be unable to complete its review of aircraft crash/cruise missile matters until June 2001.

Because the evidentiary hearing sessions currently scheduled for July 2001 are to involve the intervenors' aircraft crash/cruise missile, geotechnical, and environmental contentions, it seems apparent that the general schedule for this proceeding, most recently updated on September 5, 2000, will need to be revised. As part of the joint report, PFS and the staff supported holding an evidentiary hearing on contention Utah K/Confederated Tribes B, Inadequate Consideration of Credible Accidents, in late July 2001; however, the joint report supplement now makes it apparent this is not possible. Thus, notwithstanding our previously expressed concerns about "backloading" this proceeding, see Licensing Board Memorandum and Order (General Schedule Revision, Withdrawal of Contentions Utah H and Utah U, and Status of Contention Utah GG) (Sept. 5, 2000) at 2 (unpublished), we accept the parties' recommendation that an evidentiary hearing on the remaining admitted issues be scheduled for November and December 2001, and provide associated changes in affected schedule dates for discovery and other filings.

The general schedule for this proceeding is <u>revised</u> as is reflected in attachment A. It is so ORDERED.


