Gentlemen:

On August 31, 2000, we issued the draft improved license renewal guidance documents for public comment. Your organizations provided comments in response to our request. We appreciate your comments and have evaluated them, along with comments submitted by industry representatives and groups to develop appropriate changes in the guidance documents.

Since October 2000, when the comment period closed, we have held several public meetings with the industry groups to discuss their comments and describe changes to the guidance documents. UCS and NIRS are on the distribution for our meeting notices, and we have asked for an opportunity to meet with UCS and NIRS to discuss your comments.
