Application for Order and Conforming Amendments for License Transfer

In the above referenced application, Northeast Nuclear Energy Company (NNECO) and Dominion Nuclear Connecticut, Inc. (DNC) applied for NRC's consent and conforming license amendments to transfer the operating licenses for the Millstone Nuclear Power Station (Millstone) Units 1, 2 and 3 to DNC. This letter provides additional information supplementing and supporting that application.


On December 14, 2000, NNECO notified the NRC that two Unit 1 spent fuel pins are currently unaccounted for. These spent fuel pins are identified as the pins with serial numbers BP0406 and BK0136 from fuel bundle MS 557. DNC, NNECO, and the current owners of Unit 1, The Connecticut Light and Power Company and Western Massachusetts Electric Company, have agreed that acquired assets under the Purchase and Sale Agreement shall include these two spent fuel pins, and that DNC shall be considered the person licensed by the NRC to possess these fuel pins, unless it is later determined that these fuel pins were previously transferred to a person authorized by the NRC to receive and possess them. NNECO and the current Unit 1 owners have indemnified DNC against costs or liability that may arise from the missing spent fuel pins, so this situation will have no effect on DNC's financial qualifications. This indemnity is supported by the fact that the current Unit 1 owners are and will continue to be electric utilities as defined by the NRC in 10 CFR 50.2. Moreover, in the event that the current Unit 1 owners fail to maintain investment grade securities ratings, DNC will be further protected by an irrevocable, unconditional standby letter of credit having a drawing amount of at least \$25 million, or equivalent financial assurance.






