Dear Sir:

The NRC recently issued License Amendment No. 269 (Reference 1) which revised certain pages of the Current Technical Specifications (CTS) with regards to GL 99-02. In this License Amendment the NRC stated the CTS changes were not reflected in the ITS submittal (Reference 3) which proposed conversion of the CTS to the ITS. Accordingly, the NRC requested that the Licensee provide a schedule for submission of the ITS change pages which reflect incorporation of License Amendment No. 269 into the ITS submittal.

Consistent with the schedule presented in our letter dated October 23, 2000 (Reference 2) regarding future revisions of the ITS submittal, Entergy will provide revised ITS change pages which reflect incorporation of License Amendment No. 269 by May 31, 2001. This commitment is reflected in Attachment 1 to this letter.


