SUBJECT: REQUEST FOR EXEMPTION FROM A SCHEDULAR REQUIREMENT OF 10 CFR
50.49, ENVIRONMENTAL QUALIFICATION OF EQUIPMENT

Re: James A. FitzPatrick Nuclear Power Plant

By letter dated March 11, 1983, you requested a schedular exemption from the requirements of Section 50.49 of 10 CFR 50. The schedule pertained to information to be submitted by May 20, 1983 regarding the environmental qualification of equipment.

During discussions on May 9, 1983 between J. Gray of your staff, F. Apicella (the backup FitzPatrick Project Manager) and me, the need and supporting justification for the exemption was discussed, as well as several alternatives for meeting the requirements of the rule. As a result of those discussions, it was our understanding that you intended to meet the May 20, 1983 submittal date. Based on this understanding, we plan to take no further action regarding your exemption request.
