

PADEP Registration ID No. 50-58774

Dear Mr. Reber:

This letter addresses the request for additional information dated February 13, 2001, from you regarding the above reference License.

a. Describe the control over the radiation safety program that will be delegated so that the consultant-RSO will be able to exercise authority over authorized users when confronted with radiation safety problems that require implementation of corrective actions.

Mr. Syd Porter, CHP has worked with Lockheed Martin at the East Windsor, Valley Forge, Chestnut Street and CPC Facilities. The professional relationship exceeds 20 years. Mr. Porter is available, and communicates routinely with Lockheed Martin personnel via email, telephone, written correspondence and onsite meetings. The CPC Management, ESH professionals and radiation workers have an open working relationship with Mr. Porter and rely on his expertise for radiation safety matters. As the acting RSO, Mr. Porter provides oversight of the entire radiation safety program and provides consulting advice and direction on non-urgent matters. In emergency situations, Mr. Porter can be at either facility within 1 hour and 15 minutes and acts as the incident commander for both facilities. In the event of radiation safety problems that require implementation of corrective actions, Mr. Porter has the full support of the CPC Management and ESH Staff.

b. Describe the relationship that will exist between the consultant-RSO and your institutional management regarding expenditure of funds to facilitate the objectives of your radiation safety program and related regulatory requirements.

Once again, Mr. Porter has a long standing relationship with Lockheed Martin in excess of 20 years providing radiation safety expertise. At no time has there been an instance when Mr. Porter has made recommendations that were not considered prudent or were not implemented at the facility. Mr. Porter has the full support of the CPC Management and ESH Staff.

c. Identify other commitments of the consultant-RSO for other NRC or Agreement State licensed facilities, along with a description of how the consultant-RSO will allocate time to permit the performance of the duties of the RSO as described in the regulations. State the consultant-RSO's minimum amount of on-site time (hours per week).

Mr. Porter has ongoing commitments to the following licensed facilities.

- Permagrain - Pennsylvania Department of Environmental Protection, Bureau of Radiological Policy
One day per month

- Philadelphia College of Optometry
Two days per month

For the Lockheed Martin CPC facility, Mr. Porter spends an average of 8 hours per week at each location.

d. Appoint an in-house representative who will serve as the point of contact during the RSO's absence. This person may be allowed to assist the consultant RSO with limited authority.

The in-house representatives for the CPC and Valley Forge facilities are as follows:

CPC facility -- Ms. Clare LumKong
Valley Forge facility -- Mr. Christian Kane

e. Describe the overall availability of the consultant-RSO to respond to questions or operational issues that arise during the conduct of your radiation safety program and related regulatory requirements. Specify the maximum amount of time it will take the RSO to arrive at the facility in the event of an emergency that requires his presence.


Mr. Porter is available via email, fax, office telephone and cellular telephone. Through the cellular telephone, Mr. Porter is available 24 hours per day, 7 days per week. In the event of an emergency that requires Mr. Porter's presence at either location, the response times are as follows:

CPC facility -- 1 hour 15 minutes
Valley Forge facility -- 20 minutes

In the event that Mr. Porter is out of town or otherwise unavailable, an alternate Certified Health Physicist is on call. Mr. Richard Shimko, CHP, is also available via telephone.
