This letter is provided in response to the request from your office dated November 30, 2000,⁽¹⁾ to furnish the written examination and operating test by January 26, 2001, for Senior Reactor Operator Initial Examinations at Millstone Unit No. 2.

Pursuant to 10 CFR 55.40(b)(3), an authorized representative of the facility has approved the examination material contained in Attachment 1 prior to submittal to the Nuclear Regulatory Commission. The examination material included within Attachment 1 was developed in accordance with the guidelines contained in the examiners standard ES-401, "Preparing Initial Site-Specific Written Examinations," and ES-301, "Preparing Initial Operating Tests," of NUREG 1021, Revision 8. It is our belief that the enclosed materials are complete and ready-to-use.

Consistent with the guidance contained in NUREG 1021, ES-201, Attachment 1, "Examination Security and Integrity Considerations," the examination material contained in Attachment 1 should be withheld from public disclosure until after the examination has been completed. No redacted versions are being supplied.


