Calvert Cliffs Nuclear Power Plant, Inc. (CCNPP) committed to use the methodology developed by the Seismic Qualification Utility Group as documented in the Generic Implementation Procedure Revision 2, for the resolution on Unresolved Safety Issue (USI) A-46 (Reference a). We submitted our summary report for the resolution of USI A-46 (Reference b), that indicated that we would resolve all of the outliers by June 30, 2001. In Reference (c), the Nuclear Regulatory Commission (NRC) Staff provided its approval of the manner of implementation of the Seismic Verification Project and the resolution of USI A-46 at CCNPP. In the safety evaluation report, the NRC stated that CCNPP needed to resolve two outliers associated with the control room ventilation system. All fieldwork associated with these two outliers is now complete and these outliers are considered resolved.


In accordance with Supplement No. 1 to Generic Letter 87-02 and Part II, Section 9.5 of the Generic Implementation Procedure, a completion letter is required to be sent to the NRC advising that the corrective actions to resolve the identified outliers has been completed. This letter serves to inform the

NRC that all outliers identified in the summary report and associated with the resolution of USI A-46 at CCNPP have been resolved. This completes all CCNPP actions in response to Generic Letter 87-02, Supplement No. 1.
