

The purpose of this modification is to:

1. Exercise option year one of the contract in accordance with Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause F.4, entitled, "Duration of Contract Period," thereby extending the contract period of performance through April 30, 2002. As a result of this action, the contract ceiling is hereby increased from \$77,232.40 by the total ceiling amount for option year one of \$80,307.20 to \$157,539.60.
2. Obligate FY'01 funds in the amount of \$11,000.00, thereby increasing the obligated amount of the contract from \$47,000.00 to \$58,000.00.

Accordingly, the contract is hereby modified as follows:

- (1) Under Subsection B.4, Consideration and Obligation/Contract Ceiling, Paragraphs a and b are deleted in their entirety and substituted in lieu thereof the following:

"B.4. CONSIDERATION AND OBLIGATION/CONTRACT CEILING  
(JUN 1988)

- a. The total estimated amount (ceiling) for the work specified in Section C herein shall not exceed \$157,539.60.
- b. The amount presently obligated with respect to this contract is \$58,000.00. This amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

- (2) Subsection F.4, Duration of Contract Period is deleted in its entirety and substituted in lieu thereof the following:

"F.4 DURATION OF CONTRACT PERIOD

The contract shall commence on May 1, 2000, and will expire on April 30, 2002. The term of this contract may be extended at the option of the Government for an additional one-year option period."

A summary of obligations for this contract, from date of award through the date of this action is provided below:
