

The purpose of this modification is to: (a) exercise Option Year One in accordance with Section I.3, 52.217-9, Option to Extend the Term of the Contract (MAR 1989); and (b) revise Section G.4, 2052.216-71, Indirect Cost Rates, to incorporate the actual rates for the period 01/01/98 through 12/31/98, and incorporate the provisional rate. The Contractor's 02/07/01, e-mail relating to the provisional rate is hereby incorporated by reference. This modification results in the following changes: (1) a revision to Item 15G of Standard Form 26, increasing the total contract ceiling amount by \$3,384,194.35, from \$9,780,793.92, to \$13,164,988.27; (2) a revision to Section F.5, extending the expiration date of this contract from April 6, 2001, to April 6, 2002; and (3) a revision to Section G.4, incorporating final indirect cost rates for the period 1/1/98-12/31/98. Accordingly, the contract is modified as follows:

- Item 15G of Standard Form 26 is amended to increase the total contract ceiling amount by \$3,384,194.35, from \$9,780,793.92, to \$13,164,988.27. Item 15G is amended to read:

15G. TOTAL AMOUNT OF CONTRACT \$13,164,988.27

- Section F.5, DURATION OF CONTRACT PERIOD (MAR 1987) Alternate 4 (JUN 1988), is deleted entirely and replaced with the following:

The ordering period for this contract shall commence on April 7, 1998, and will expire on April 6, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional one (1) one-year option period.

- Under Section G.4, INDIRECT COST RATES, paragraph (a) is deleted entirely and replaced with the following:

(a) Pending the establishment of final indirect rates which must be negotiated based on audit of actual costs, the contractor shall be reimbursed for allowable indirect costs as follows:

G&A/Overhead Rate - 69.8% for the Period 1/1/02 - 12/31/02
G&A/Overhead Rate - 69.8% for the Period 1/1/03 - 12/31/03

As a result of this modification, the ceiling amount is increased to \$13,164,988.27. All other terms and conditions remain the same.
