Subject: Braidwood Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, Revisions 51, 52, and 53

In accordance with 10 CFR 50.54 (p)(2), "Conditions of licenses," we are submitting a change to the Exelon Generation Company, LLC, Braidwood Station Security Plan, the Security Personnel Training and Qualification Plan, which is Appendix B to the Braidwood Station Security Plan, and the Safeguards Contingency Plan, which is Appendix C to the Braidwood Station Security Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three (3) copies of the Braidwood Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, Revisions 51, 52, and 53.

Revision 51 includes the following change.

The Security Plan has been revised to remove unnecessary information from the definition of "bullet resistant" structures. This change is considered editorial and does not change the intent of the definition.

Revision 52 includes the following change.

The Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan have been revised to replace/modify the description of the security organization with a new organizational structure. New descriptions have been added for Corporate Nuclear Security, the Regional Operating Group (ROG), and Site Nuclear Security. Other changes, including position and title name changes, were also required. All changes are considered editorial and were made due to the company's reorganization resulting from the merger between Unicom Corporation and PECO Energy Company.

## **SAFEGUARDS INFORMATION**

Revision 53 includes the following change.

The Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan have been revised to replace all references to the previous company name with the new company name, Exelon Generation Company, LLC (i.e., Exelon).

As required by 10 CFR 50.54(p)(2), we have concluded that these changes do not decrease the safeguards effectiveness of the Braidwood Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan.

These changes to the Braidwood Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan were implemented on January 11, 2001. In accordance with 10 CFR 50.54 (p)(2), these changes shall be reported within 60 days of implementation (i.e., by March 12, 2001).

Attachments 4, 5, and 6 contain Safeguards Information that must be protected from public disclosure as required by 10 CFR 73.21, "Requirements for the protection of safeguards information."
