

The purpose of this modification is to exercise and fund CLIN 3b and extend the duration of the contract to 11/30/01. Accordingly, the contract is hereby modified as follows:

1. In accordance with C.4 of the contract, CLIN 003b is hereby exercised in the amount of \$446,310. As a result the total contract price is increased by \$446,310 from \$718,206 to \$1,164,516. Therefore Section B.6 is modified accordingly:

"B.6 CONSIDERATION AND OBLIGATION - FIRM FIXED PRICE

The firm fixed price of the contract for the period set forth in B.5 is \$1,164,516. Contract prices for future option periods are set forth in Section B.3."

2. Section B.5, DURATION OF CONTRACT, is replaced with the following:

"B.5 DURATION OF CONTRACT Alternate 2 (MAR 1987)

This contract commenced on 12/1/1999 and will expire on 11/30/01. The term of this contract may be extended at the option of the Government for additional periods as shown in Section B.3."
