
Dear Ms. Long:

Dear Sir or Madam:

This is a request pursuant to the Freedom of Information Act, 5 U.S.C. §552. I ask that you provide me with copies of the following documents relating to the Shpack Landfill Superfund and FUSRAP site ("Shpack") in Norton and Attleboro, Massachusetts:

- 1) any and all studies, reports, investigations, site assessments, environmental monitoring results, correspondence, internal memoranda and other writings prepared by the Nuclear Regulatory Commission ("NRC") or Department of Energy ("DOE"), their employees, agents, officials, authorized representatives, contractors, attorneys or predecessors which directly pertain to or describe Shpack;
- 2) any studies, reports and other writings which describe funding for or the clean up of nuclear waste at Shpack;
- 3) any and all correspondence between NRC or its predecessors and other governmental departments, agencies or officials including but not limited to, members of Congress, United States Environmental Protection Agency, town of Norton, Norton Board of Health, Norton Conservation Commission, City of Attleboro, Attleboro Health Department, Attleboro Conservation Commission, Massachusetts Department of Environmental Protection, Massachusetts Department of Public Health, Atomic Energy Commission or DCE about Shpack;
- 4) any and all contracts for studies or investigations of Shpack;

- 5) any and all documents or writings which describe or pertain to Shpack's inclusion in the Formerly Utilized Remedial Action Project ("FUSRAP"), including any studies, investigations or records which were examined in making the decision to include Shpack in FUSRAP;
- 6) any and all documents or writings which are or were at any time contained in the file maintained by NRC or its predecessors on Shpack;
- 7) any and all reports or notes of interviews conducted regarding Shpack;
- 8) any and all data collected and lists made regarding the extent, nature or sources of contamination at Shpack;
- 9) any and all correspondence between NRC or its predecessors and Oak Ridge National Laboratory or Bechtel National regarding Shpack;
- 10) any and all responses to requests for information filed by potentially responsible parties or other persons in connection with Shpack including any enclosures or appendices thereto;
- 11) any and all other written information in the possession of NRC, its employees, agents, officials, authorized representatives, contractors, attorneys or predecessors which describes or refers to the sources or types of contamination discovered at Shpack;
- 12) any and all written information in the possession of NRC, its employees, agents, officials, contractors, or predecessors regarding the removal of any materials from Shpack; and
- 13) any and all written information regarding an award or reward to John Sullivan with respect to Shpack.
