Subject: LaSalle County Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, Revision 66.

In accordance with 10 CFR 50.54(p)(2), "Conditions of licenses," we are submitting a change to the Exelon Generation Company, LLC, LaSalle County Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three (3) copies of Revision 66.

Revision 66 includes the following change.

The Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, have been revised to replace the all references to the previous company name or acronyms thereof with the new company name: Exelon Generation Company, LLC.

As required by 10 CFR 50.54(p)(2), we have concluded that this change does not decrease the safeguards effectiveness of the LaSalle County Station Security Plan, Security Personnel Training and Qualification Plan, or Safeguards Contingency Plan.

The change to the LaSalle County Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, was implemented on January 10, 2001. In accordance with 10 CFR 50.54(p)(2), these changes shall be reported within 60 days of implementation i.e., March 11, 2001.
