ORDER

(Corrections to LBP-01-09)

The Licensing Board revises LBP-01-09 to incorporate the following corrections:

1. On page eight, line twelve of the slip opinion, place a comma after the word “analysis” and insert the phrase “the so-called ERIN report,”.
2. On page eight, lines fourteen and fifteen of the slip opinion, change the word “Erin” to read “ERIN”.
3. On page eight, line twenty-one and twenty-two of the slip opinion, change the phrase “an August 1993 individual plant examination (IPE)” to read “the August 1993 IPE”.
4. On page nine, line three of the slip opinion, insert the parenthetical “(Apr. 1994)” after the word “Mountains”.
5. On page nine, line eighteen of the slip opinion, after “(a)”, insert “Oral Argument. –”.
6. On page ten, revise the beginning of line five of the slip opinion to read “party . . . to submit”.
7. On page ten, line six of the slip opinion, delete the word “that” and substitute “upon which”.

8. On page ten, line seven of the slip opinion, after “(b)”, insert “Adjudicatory Hearing. –“.
9. On page ten, line nine of the slip opinion, delete the word “issues” and substitute the word “questions”.
10. On page ten, line ten of the slip opinion, delete the last of the three hyphens.
11. On page eleven, line fourteen of the slip opinion, insert the word “the” between the words “of” and “staff’s”.
12. On page fifteen, line six of the slip opinion, place a hyphen between the words “seven” and “step”.
13. On page eighteen, line six of the slip opinion, change the phrase “a CDF” to “the CDF”.
14. On page eighteen, line nine of the slip opinion, insert a comma after the word “accident”.
15. On page eighteen, lines twelve and fifteen of the slip opinion, change the word “Erin” to read “ERIN”.
16. On page twenty-four, line twelve of the slip opinion, place a hyphen between “200” and “meter”.
17. On page twenty-six, line one of the slip opinion, place a hyphen between “accident” and “generated”.
18. On page twenty-six, line twenty-three of the slip opinion, change the phrase “make up” to “makeup”.
19. On page twenty-seven, line one of the slip opinion, revise the phrase “makeup due” to read “makeup systems due”.
20. On page twenty-eight, line twelve, change the phrase “make up” to “makeup”.

21. On page thirty-two, line thirteen of the slip opinion, change the word “Erin” to read “ERIN”.
22. On page thirty-three, line thirteen of the slip opinion, place a comma after the word “room”.
23. On page thirty-three, line twenty-two of the slip opinion, delete the word “the” before the word “steps”.
24. On page thirty-four, line five of the slip opinion, delete the word “Therefore” and capitalize the word “All”.
25. On page thirty-four, line six of the slip opinion, delete the phrase “it is prudent”.
26. On page thirty-five, line one of footnote nine of the slip opinion, place a comma after the word “context”.
27. On page thirty-six, line twenty of the slip opinion, place the word “not” between the words “as” and “falling”.

28. On page thirty-seven, line six of the slip opinion, delete the word "higher" and substitute the word "lower".
