In accordance with 10 CFR 50.54(p)(2), "Conditions of licenses," we are submitting a change to the Exelon Generation Company, LLC Quad Cities Nuclear Power Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three (3) copies of Revision 52.

Revision 52 includes the following change.

The Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, have been revised to replace the all references to the previous company name or acronyms thereof with the new company name: Exelon Generating Company, LLC (i.e., Exelon).

As required by 10 CFR 50.54(p)(2), we have concluded that this change does not decrease the safeguards effectiveness of the Quad Cities Nuclear Power Station Security Plan, Security Personnel Training and Qualification Plan, or Safeguards Contingency Plan.

The change to the Quad Cities Nuclear Power Station Security Plan, Security Personnel Training and Qualification Plan, and Safeguards Contingency Plan, was implemented on January 9, 2001. In accordance with 10 CFR 50.54(p)(2), these changes shall be reported within 60 days of implementation (i.e., by March 10, 2001).
