Each sealed source container (capsule) of licensed material to be used outside of a shielded device shall have permanently attached to it a duragle, legible and visible tag. The tag shall be attached directly to the container (capsule), or by the use of a durable chain or leader. The tag shall be at least ene inch square and shall bear a radiation caution symbol in conventional colors, magenta or purple on a yellow background, and a minimum of the following instructions: "Danger - Radioactive Material - Do Not Handle - Notify Civil Authorities if Found."

15. Leak testing of the Oak Ridge National Laboratory Cobalt 60 sealed source licensed as 460 milliouries activity shall be carried out at intervals of not more than six months and records of leak test results shall be furnished the Atomic Energy Commission upon request.
