SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE -  
FRAMATOME ANP RICHLAND, INC. (TAC NO. MB0574)

Dear Mr. Mallay:

Framatome ANP Richland, Inc. (FRA-ANP) submitted by letter dated November 7, 2000, Topical Report EMF-2361(P) Revision 0, "EXEM BWR-2000 ECCS Evaluation Model," for NRC review and approval. In support of this submittal, by your letter dated March 1, 2001, and affidavit executed on March 1, 2001, you submitted a compact disk (CD) containing the codes RELAX, PREHUXY, and HUXY as well as selected test cases. The CD also contains: (a) additional codes and files necessary to execute the test cases, (b) users manuals for the main codes, and (c) a description of the contents of the CD, instructions for copying the information from the CD, and directions for executing the test cases. Your letter stated that the CD was considered to be proprietary and requested that the CD be withheld from public disclosure pursuant to 10 CFR 2.790. A nonproprietary version of the CD was not submitted for placement in the NRC public document room or added to the Agencywide Documents Access and Management Systems Publicly Available Records System (ADAMS PARS) Library.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (a) The information reveals details of FRA-ANP's research and development plans and programs or their results.
- (b) Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- (c) The information includes test data or analytical techniques concerning a process, methodology, or component, the application of which results in a competitive advantage for FRA-ANP.
- (d) The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for FRA-ANP in product optimization or marketability.

- (e) The information is vital to a competitive advantage held by FRA-ANP, would be helpful to competitors to FRA-ANP, and would likely cause substantial harm to the competitive position of FRA-ANP.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.790 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the CD containing the codes RELAX, PREHUXY, and HUXY as well as selected test cases, enclosed with your March 1 letter, and marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
