ISSUANCE OF CONFORMING AMENDMENTS (TAC NOS. MA9876, MA9877,  
AND MA9899)

Dear Mr. Lizotte:

By Order dated March 9, 2001, the U.S. Nuclear Regulatory Commission (NRC) approved the transfer of the licenses for Millstone Nuclear Power Station, Unit Nos. 1, 2, and 3, (MP1, MP2, and MP3) to Dominion Nuclear Connecticut, Inc., (DNC), and approved the conforming amendments pursuant to Sections 50.80 and 50.90 of the *Code of Federal Regulations*.

By letter dated March 21, 2001, DNC informed the NRC that the closing of the license transfer might occur as early as March 30, 2001, and that all required regulatory approvals have been obtained. By letter dated March 26, 2001, DNC provided documentary evidence that DNC has obtained the appropriate amount of insurance required of licensees by 10 CFR Part 140 and 10 CFR 50.54(w). The March 21 and 26, 2001, letters satisfied required conditions of the March 9, 2001, Order. On March 30, 2001, Northeast Nuclear Energy Company verbally notified the NRC that the closing of the transfer would occur on March 31, 2001.

Accordingly, the Commission has issued the enclosed Amendment No. 109 to Facility Operating License No. DPR-21 for MP1, Amendment No. 256 to Facility Operating License No. DPR-65 for MP2 and Amendment No. 196 to Facility Operating License No. NPF-49 for MP3. These conforming amendments reflect the transfer of the Selling Owners' interests in MP1, MP2, and MP3 to DNC and transfer of Northeast Nuclear Energy Company's operating authority under the licenses to DNC. The safety evaluation supporting the conforming amendments was enclosed with the Order issued on March 9, 2001.
