The purpose of this meeting was to discuss the risk aspects of fires occurring in the Emergency Switchgear Rooms (ESGRs) of North Anna Power Station, Units 1 and 2. The staff is conducting an evaluation of the potential reduction of risk associated with replacing the manually initiated Halon system in the ESGRs with an automatically initiated system.

VEPCO's Individual Plant Examination of External Events (IPEEE) report for North Anna included an analysis of the risk due to fires occurring in the ESGRs. This report was extensively discussed to ensure the staff and consultants fully understood the evaluation performed as well as the information contained within the report. The meeting participants discussed the computer code and assumptions used to model fire initiation, growth, and subsequent equipment damage in the room. VEPCO described the types of equipment that were located in the ESGRs, the layout of the equipment within these ESGRs, and the firefighting procedures and practices specifically applicable to fires in the ESGRs.
