Dear Sir:

On December 21, 2000 the Nuclear Regulatory Commission issued Amendment 1 to the 10 CFR 72 Certificate of Compliance (CoC) and Safety Evaluation Report for the HI-STAR 100 dry cask spent fuel storage system. The amended CoC became effective on December 26, 2000. In accordance with 10 CFR 72.248(a)(1), enclosed herewith please find one copy of Holtec Report No. HI-2012610, Revision 0, comprising the HI-STAR 100 System Final Safety Analysis Report (FSAR). As you are aware, the provisions of 10 CFR 72.248 were not in effect at the time of original certification of the HI-STAR 100 System in October, 1999. Therefore, an FSAR was not issued at that time and TSAR Revision 10 (Holtec Report HI-941184) has been the SAR of record until now. The HI-STAR FSAR supersedes Revision 10 of the HI-STAR TSAR in its entirety. The following differences are noted:


1. Conforming changes to reflect Amendment 1 to the CoC are included.
