This letter is to inform you of a change in management of the Millstone Nuclear Power Station. Mr. Leon J. Olivier, currently the Senior Vice President and Chief Nuclear Officer of Northeast Nuclear Energy Company (NNECO), has announced that he will be leaving Millstone Power Station at the time of the transfer of the NRC operating licenses to Dominion Nuclear Connecticut, Inc., to pursue another career opportunity. This change in management is not part of the transfer of the station or a management change being effected by DNC. Mr. William R. Matthews, currently Virginia Power's Vice President – Nuclear Operations, will assume the position Senior Vice President – Millstone after Mr. Olivier's departure. Mr. Matthews' resume is attached.



## **William R. Matthews**

William R. Matthews, currently Vice President - Nuclear Operations, joined Virginia Power in November 1972. He is a native of Dover, New Jersey.

He served in the United States Navy for 7 years before joining Virginia Power as an Assistant Control Room Operator at Surry Power Station. He became a Control Room Operator in February 1975 and was promoted to Assistant Shift Supervisor in July 1977. In December 1977 he received his Senior Reactor Operator License from the NRC. In March 1979 he was promoted to Shift Supervisor.

In March 1980 Mr. Matthews resigned from Virginia Power to join Electronics Associates, Inc. in West Long Beach, New Jersey as senior member technical staff responsible for review of the preliminary design of the Nuclear Basic Principles Training Simulator.

In September 1984 he returned to Virginia Power as Supervisor - Operations and Maintenance in the Richmond general office and was promoted to Director - Operations and Maintenance Support in April 1988. In November 1988 he assumed the position of Superintendent - Maintenance at North Anna Power Station.

In December 1993 Matthews assumed the position of Assistant Station Manager - Operations and Maintenance, North Anna Power Station. In May 1996 he was promoted to Station Manager - North Anna Power Station and subsequently, Site Vice President.

On May 1, 2000 Mr. Matthews was promoted to Vice President - Nuclear Operations. As Vice President - Nuclear Operations, he is responsible for the day-to-day operations of the company's two nuclear plants, the administration of contracts, and the company's interface with regulating agencies on nuclear issues.
