CAROLINA POWER & LIGHT COMPANY'S OPPOSITION TO ORANGE COUNTY'S MOTION FOR LEAVE TO REPLY AND SUPPORT OF THE NRC STAFF'S MOTION TO STRIKE

Carolina Power & Light Company ("CP&L") opposes the motion of the Board of Commissioner's of Orange County, North Carolina ("BCOC") for leave to reply to CP&L's and the NRC Staff's Answers to BCOC's Emergency Stay Request and Petition for Review. Commission regulations specifically state that "the petitioning party shall have no right to reply," 10 C.F.R. § 2.786(b)(3), and that "[n]o further replies to answers will be entertained." 10 C.F.R. § 2.788(d). BCOC's attempt to obtain special Commission permission to reply is particularly inappropriate here, where BCOC has already grossly exceeded the argument allotted to it pursuant to the very regulations it now attempts to invoke.²

CP&L also supports the NRC Staff's Motion to Strike certain portions of Dr. Gordon Thompson's Declaration of March 16, 2001. In addition to the reasons identified by the Staff in its Motion, CP&L respectfully suggests that the Commission should not tolerate BCOC's unprofessional attacks on the integrity of the Licensing Board, in the guise of a declaration, in a futile attempt to rehabilitate Dr. Thompson's inadequacies. As CP&L and the Staff have consistently stated, Dr. Thompson's work speaks for itself.
