As a part of that Order, the Detailed Control Room Design Review Summary Report was scheduled for January 1, 1985.

We have reviewed your letter dated December 12, 1984 requesting a schedular extension from January 1, 1985 to July 1, 1985 for the Detailed Control Room Design Review Summary Report. We concur that an expanded Summary Report encompassing our in-progress audit comments as well as the details of the major items (Fire Panel, Process Computer, Human Factors Manual, the Integrated Cosmetics Package and your Implementation/Interaction Program) discussed in your December 12, 1984 letter would be more efficient in completing the review of the Detailed Control Room Design Review and your associated proposed changes, since it would eliminate the need for supplementing your initial report.

In view of the above, and since your proposed completion date is within the time frame we have found acceptable for other facilities and the proposed schedular extension would not impact the overall schedule for completion of the NUREG-0737, Supplement 1 program (Spring 1986 Refueling Outage), we find the request acceptable. Accordingly, pursuant to Section IV of the Order, the time for submittal of the Detailed Control Room Design Review Summary Report is hereby extended to July 1, 1985.
