SUBJECT: RETYPED APPENDIX A TECHNICAL SPECIFICATIONS (TAC 61450)

Re: Nine Mile Point Nuclear Station, Unit No. 1

In a January 30, 1986 meeting with members of the staff, we stated that the staff was having your Appendix A Technical Specifications (TS) retyped. For a number of your past licensing actions we have had to retype complete pages of the TS before issuing the action. In addition, your TS are a collection of several different formats and typing styles.

Enclosed are the retyped TS for Nine Mile Point Unit 1. This document has been proofread by the staff and its contractor; however, we request that you review this document and provide us with any needed corrections before issuance of the official TS for Nine Mile Point Unit 1. This document is complete up to Amendment 88, Radioactive Liquid Effluent Monitoring Instrumentation, dated October 6, 1986. The TS have been retyped word-for-word except for cases where misspelled words have been corrected. The pages have been renumbered and reorganized to more closely represent the standard form. The TS are now in the following form:

4. Bases for Section 2.0
5. Sections 3.0 and 4.0 - Limiting Conditions for Operation and Surveillance Requirements

8. Section 6.0 - Administrative Controls

The retyped TS also include copies of the figures in the existing TS. We request that you provide new originals for these figures on a schedule to be negotiated with the NRC Project Manager.
