The purpose of this modification is to: (1) to increase the estimated quantity of general furniture items to be disposed of set forth in Article I.A, (2) to increase the estimated value of Scope Area A set forth in Article V.B (1) and (3) to provide incremental funding in the amount of \$4,000 thereby increasing the obligated amount of this Agreement from \$50,000 to \$54,000. Accordingly, the Agreement is hereby modified as follows:


1. Under Article I.A entitled Excess And Disposal Services for General Furniture Items, the third paragraph is changed to read as follows: "2400 items per year x \$8.33 per item = \$19,992 per year."
2. Under Article V.B(1) entitled "The Estimated Value of Services in Each Services Area", the estimated value for Scope Area A is changed to read: "Scope Area A - Excess General Office Furniture - \$59,976 for the three year period." The total amount of this IAG is increased to \$80,109.60.
3. Under Article V entitled "ESTIMATED AGREEMENT VALUE AND ACCOUNTING AND APPROPRIATION DATA," paragraph A., "Accounting Data," REVISE the accounting data for "Current amount funded" to read as follows:

Obligated amount of this action \$4,000  
Total Cumulative obligated amount: \$54,000.00"

4. All other terms and conditions of this Interagency Agreement remain unchanged.


