This modification provides incremental funding in the amount of \$108,000, thereby increasing the contract's obligated amount from \$1,084,839.00 to \$1,192,839.00. Accordingly, Subsection B.3 "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE, paragraph (c) is modified to read "(c) The amount currently obligated by the Government with respect to this contract is \$1,192,839.00, of which the sum \$1,114,803.00 represents the estimated reimbursable costs, and of which \$78,036.00 represents the fixed fee." All other terms and conditions of the contract remain unchanged.
