The purpose of this modification is to extend the period of performance for eight months. Accordingly, the following changes are hereby made:

1. Section B.3, CONSIDERATION AND OBLIGATION-COST REIMBURSEMENT (JUN 1988), paragraph(b) is deleted in its entirety and replaced with the following:
