Safeguards Contingency Plan, Revision 4

Pursuant to 10 CFR 50.54(p)(2), Dominion Nuclear Connecticut, Inc. (DNC) hereby submits Revision 4 to the Millstone Power Station Safeguards Contingency Plan (SCP). A description of the changes to the SCP is contained in Attachment 1. The revision to the SCP is provided as Enclosure 1.

The Millstone Power Station Site Operations Review Committee has evaluated the revision pursuant to 10 CFR 50.54(p) and concurs that it does not decrease the effectiveness of the SCP. Pursuant to 10 CFR 73.21(b), the SCP is considered safeguards information and, as such, DNC requests that Enclosure 1 be withheld from public disclosure pursuant to 10 CFR 2.790(d)(1). Upon separation of Enclosure 1 the remainder of this letter may be decontrolled.

There are no regulatory commitments contained within this letter.

Description of Changes to the Safeguards Contingency Plan, Revision 4

This revision of the Safeguards Contingency Plan (SCP) is being submitted to reflect the following changes made pursuant to 10 CFR 50.54(p). It includes the following updates:

1. Chapter 1, "Background," has been revised to change the name of the station from the "Millstone Nuclear Power Station" to the "Millstone Power Station" in the body of the document and within the definitions section.

The definitions for the "Northeast Nuclear Energy Company (NNECO)" and "Northeast Utilities (NU)" have been removed. References to these titles have been replaced with the term "Licensee" due to the sale of the Millstone Power Station.

The position of "Station Superintendent" has been removed and the duties and responsibilities outlined in the plan have been transferred to the "Unit 3 Operations Shift Manager." Also, the following titles have been updated as follows:

Operations Shift Supervisor	Operations Shift Manager
Security Chief	Project Manager
NNECO Security Shift Supervisor	Security Shift Supervisor
Security Supervisor	Process Owner - Protective Services
Assistant Security Supervisor - Operations	Team Lead - Security Operations

2. Chapter 2, "General," has been revised to remove reference to the titles "Northeast Nuclear Energy Company (NNECO)" and "Northeast Utilities (NU)" and replace them with the term "Licensee," as the Single Point of Contact and the authority for implementing Emergency Plan actions during a security threat.

Typographical errors in reference to the Waterford Fire Department and Troop E, Connecticut State Police have been corrected.

The reference to the procedure entitled "Security Alert" has been revised to reflect the current procedure title of "Potential Security Threat."

3. Chapter 3, "Licensee Planning Base," has been revised to change the title of the position of "Security Chief" to "Project Manager."

References to Figure 3-1, NUSCO Security Organization, and Figure 3-2, NNECO Station Security Organization previously contained in the Physical Security Plan have been removed. These figures were removed from the PSP.

The former requirement to provide copies of the Safeguards Contingency Plan and procedures to the "Chief of Security" (now the Project Manager) is being revised. Copies of the SCP and procedures are made available for contractors to view at any given time and the SCP text has been modified to reflect this.

4. Chapter 4, "Responsibility Matrix," has been revised to update position titles as outlined in the description of changes for Chapter 1.

The position of "Station Superintendent" has been removed and the duties and responsibilities outlined in the plan have been transferred to the "Unit 3 Operations Shift Manager."

Tables 4-1 through 4-30 have been revised to update position titles as outlined in the description of changes for Chapter 1.

Also, reference to the title "Northeast Utilities Service Company (NUSCO)" has been removed and replaced with the title "Licensee."
