By letter dated March 7, 2001, Duke Energy, acting on behalf of the candidates named in Attachment 1, requested an exemption from certain requirements of 10 CFR Part 55, "Operators' Licenses." Specifically, Duke Energy requested an exemption from the requirements of 10 CFR 55.31(a)(5), which requires that five significant control manipulations which affect reactivity or power level be performed on the actual plant as a prerequisite for license eligibility.

Duke Energy Corporation hereby withdraws the subject exemption request. These license operator candidates performed the required manipulations during shutdown operations for entry into the Unit 1 EOC 14 refueling outage.
