Ms. Vietti-Cook:

By Order Approving Transfer of Licenses and Conforming Amendments dated March 9, 2001, the U.S. Nuclear Regulatory Commission consented to the transfer of Millstone Nuclear Power Station, Units 2 and 3 from Northeast Nuclear Energy Company and the colicensee selling owners to Dominion Nuclear Connecticut, Inc., an indirectly, wholly-owned subsidiary of Dominion Energy which, in turn, is wholly-owned by Dominion Resources, Inc.¹ The Order was effective upon issuance, subject to the condition that should the transfer of licenses not be completed by March 9, 2002, the Order shall become null and void.

This letter will inform the Office of the Secretary and the Commission that the closing of the transaction involving the sale of Millstone Units 2 and 3 was completed on March 31, 2001. As a result, in accordance with the NRC Order, Dominion Nuclear Connecticut, Inc. ("DNC") has become the operating licensee for Millstone Units 2 and 3, acting for itself and on

¹ Dominion Nuclear Connecticut, Inc. will be the sole owner and operator of Millstone Unit 2 and will hold a 93.4707% ownership interest in Unit 3 and will be the operator on behalf of itself and Central Vermont Public Service Corporation which holds a 1.7303% interest and Massachusetts Municipal Wholesale Electric Company which holds a 4.7990% interest in Unit 3.
