Dear Mr. Mangan:

The Commission has issued the enclosed Amendment No. 1 to Facility Operating License No. NPF-54 for the Nine Mile Point Nuclear Station Unit No. 2 (NMP-2). The amendment consists of changes to the License in response to your application transmitted by letter dated March 11, 1987, as supplemented March 16, 1987.

This amendment to the License concerns deletion of License Condition 2.C.(14) on the main steam isolation valves (MSIVs). The additional changes to the License concerning the changes to the Technical Specifications to reflect the change from the MSIV ball valves to the MSIV wye-pattern globe valves will be addressed at a later time. The request to delete references to items 1.a.(2), (3), and (4) will not be acted on. These items, which concern satisfactorily addressing three outstanding construction deficiency reports under 10 CFR 50.55e, will be addressed through the normal process for construction deficiency reports.

License Condition 2.C.(14) involves confirmatory leak testing and prototype testing of the MSIV ball valve design to ensure problems with these valves that were encountered before licensing had been satisfactorily resolved. Because of continuing problems with the MSIV ball valves, Niagara Mohawk Power Corporation informed the NRC on March 11, 1987 that the MSIV ball valves would be replaced by MSIV wye-pattern globe valves from Rockwell. These valves are similar in design to the MSIVs used in most Boiling Water Reactor plants. Furthermore, Niagara Mohawk indicated in their letter of March 31, 1987 that the wye-pattern globe valves to be used at NMP-2 are almost duplicates of the MSIVs at LaSalle 1 and 2, Hanford 2, Tokai 2 and Hatch.

In Niagara Mohawk's letter of March 11, 1987 it was requested that License Condition 2.C.(14) of Operating License NPF-54 be deleted as the confirmatory testing required in that license condition was applicable only to the MSIV ball valves which were being replaced. The staff agrees that because these valves will no longer be used, the confirmatory testing required by section 2.C.(14) of the license is no longer necessary and should be deleted from the license.

This amendment involves a change in the installation or use of a facility component located within the restricted area as defined in 10 CFR Part 20. The staff has determined that the amendment involves no significant increase in the amounts, and no significant change in the types, of any effluents that may be released offsite, and that there is no significant increase in

individual or cumulative occupational radiation exposure. The Commission has previously issued a proposed finding that this amendment involves no significant hazards consideration and there has been no public comment on such finding. Accordingly, this amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR $\S51.22(c)(9)$. Pursuant to 10 CFR $\S51.22(b)$ no environmental impact statement or environmental assessment need be prepared in connection with the issuance of this amendment.

The staff has concluded, on the basis of the considerations above, that: (1) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, and (2) such activities will be conducted in compliance with the Commission's regulations and the issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public.

A Notice of Issuance will be included in the Commission's next regular bi-weekly Federal Register notice.

<u>Brief description of amendment</u>: This amendment revises the Technical Specifications related to the main steam isolation valves (MSIVs).

Also, items 1.a.(2), (3) and (4) in Attachment 1 to the License are deleted. These change result from the change out of ball valves with globe valves.
