On August 21, 2000, the Commission issued a final rule amending the NRC's regulations in Title 10 of the Code of Federal Regulations (CFR), Part 72, "Licensing Requirements for the Independent Storage of Spent Fuel and High Level Radioactive Waste." The final rule was titled "Clarification and Addition of Flexibility" and was published in the FEDERAL REGISTER at 65 FR 50606. I am enclosing a copy of this Federal Register Notice for your information.

One of the actions of this final rule was to amend 10 CFR 72.234(c) to permit a licensee or an applicant for a CoC to begin fabrication of a spent fuel storage cask, before the NRC has issued a CoC.
