18 DEBTOR'S NOTICE OF PARTIAL WITHDRAWAL OF MOTION FOR AUTHORITY
19 TO REFUND MAIN LINE EXTENSION DEPOSITS

1 PLEASE TAKE NOTICE that Pacific Gas and Electric Company, the debtor and
2 debtor in possession herein ("PG&E"), will and hereby does withdraw that portion of its
3 Emergency Motion for Authority to Refund Main Line Extension Deposits ("MLX Motion")
4 that has not been previously granted by this Court.

5 PG&E filed the MLX Motion on April 6, 2001, pursuant to Sections 105(a) and
6 507(a)(6) of Title 11 of the United States Code (the "Bankruptcy Code") and Rules 2002,
7 9006 and 9007 of the Federal Rules of Bankruptcy Procedure (the "Rules"). At a hearing on
8 the MLX Motion held on April 7, the Court entered an order granting PG&E authority to
9 refund pre-petition main line extension deposits to individual residential customers. The
10 Court scheduled for further hearing on May 9, 2001 that portion of the MLX Motion relating
11 to PG&E's non-residential and residential subdivision customers.

12 PG&E hereby respectfully withdraws the remainder of its MLX Motion without
13 prejudice to the order partially granting PG&E's MLX Motion with respect to individual
14 residential customers.
