NOTICE OF PROPOSED ISSUANCE OF AMENDMENT

TO PROVISIONAL OPERATING LICENSE

The Nuclear Regulatory Commission (the Commission) is considering issuance of an amendment to Provisional Operating License No. DPR-16 issued to Jersey Central Power & Light Company (the licensee), for operation of the Oyster Creek Nuclear Generating Station, located in Lacey Township, Ocean County, New Jersey.

The amendment would revise the provisions in the Technical Specifications to (1) allow the facility to remain in the shutdown refueling, or startup mode with reduced core spray system capability for the duration of the outage during which improvements to the ECCS system are made, and (2) provide operability requirements for the condensate system until the ECCS modifications are completed, in accordance with the licensee's application for amendment dated June 24, 1975 and supplements dated July 15, November 7, and December 1, 1975.

Prior to issuance of the proposed license amendment, the Commission will have made the findings required by the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations.

By 1/16/76, the licensee may file a request for a hearing and any person whose interest may be affected by this proceeding may file a request for a hearing in the form of a petition for leave to

All petitions will be acted upon by the Commission or licensing board, designated by the Commission or by the Chairman of the Atomic Safety and Licensing Board Panel. Timely petitions will be considered to determine whether a hearing should be noticed or another appropriate order issued regarding the disposition of the petitions.

In the event that a hearing is held and a person is permitted to intervene, he becomes a party to the proceeding and has a right to participate fully in the conduct of the hearing. For example, he may present evidence and examine and cross-examine witnesses.

For further details with respect to this action, see the application for amendment dated June 24, 1975, and supplements dated July 15, November 7, and December 1, 1975, which is available for public inspection at the Commission's Public Document Room, 1717 H Street, N. W., Washington, D. C. and at the Ocean County Library, 15 Hooper Avenue, Toms River, New Jersey 08753. The license amendment and the Safety Evaluation, when issued, may be inspected at the above locations and a copy may be obtained upon request addressed to the U. S. Nuclear Regulatory Commission, Washington, D. C. 20555, Attention: Director, Division of Reactor Licensing.
