3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on December 31, 2000. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about January 8, 2001. The containers will then be loaded onto the rail for importation to Detroit, MI. The containers will enter the USA at Detroit, MI on or about January 11, 2001, and will continue on rail to St. Louis, MO. The inland transportation from Montreal, PQ to Metropolis, IL will be the responsibility of RSB logistic Services Inc.
