SUBJECT: AMENDMENT NO. 1 TO SOURCE MATERIALS LICENSE NO. SUC-1581 TO  
EXTEND THE DUE DATE OF THE DECOMMISSIONING PLAN (TAC #L60509)

Dear Ms. Sobel:

We reviewed your letter dated March 15, 2001, requesting one year time extension to submit the decommissioning plan (DP) by August 31, 2002, under the U.S. Nuclear Regulatory Commission (NRC) License SUC-1581 for the Tobico Marsh State Game Area Site Decommissioning Management Plan (SDMP) site. We also reviewed Ms. Denise Gruben's January 18, 2001, letter requesting changes to addresses and office names referenced in the license. In accordance with Condition 11A of your NRC License SUC-1581, the DP is due to be submitted to the NRC no later than August 31, 2001. Your March 15, 2001, letter indicates that due to unforeseen waste disposal patterns discovered during site characterization work, additional investigations were undertaken to delineate those wastes, and wastes were discovered deeper resulting in additional samples and duplicate analyses requiring more time for laboratory analysis and interpretation within the larger data set. In addition, your letter also indicates that the alternate schedule is necessary to the effective conduct of decommissioning operations, presents no undue risk from radiation to the public health and safety, and is otherwise in the public interest [10 CFR Part 40.42(g)(2)].

Therefore, based on the information provided in your March 15, 2001, letter and pursuant to 10 CFR 40.42(g)(2), NRC approves extension of time to submit the DP no later than August 31, 2002. Based on Ms. Denise Gruben's January 18, 2001, letter, the address in the license is changed as requested from "611 W. Ottawa Street, Lansing, MI 48933" to "530 W. Allegan Street, Lansing, MI 48933". However, with regard to the 2<sup>nd</sup> item in Ms. Gruben's letter, the title of the Radiation Safety Committee (RSC) member is not specifically referenced in the NRC license. Therefore, no action is taken regarding the title change of the RSC member. However, the title of the RSC member will be maintained for future use.

The NRC staff has concluded that this license amendment concerns administrative changes and meets the requirements, for a categorical exclusion in accordance with 10 CFR 51.22(c)(11), because: (i) there is no significant change in the types or significant increase in the amounts of any effluents that may be released offsite; (ii) there is no significant increase in individual or cumulative occupational radiation exposure; (iii) there is no significant construction impact; and (iv) there is no significant increase in the potential for, or consequences from radiological accidents. Therefore, neither an environmental assessment nor an environmental impact statement is required.

The DP will include site characterization information necessary to support the DP and a revised decommissioning funding plan, that includes a revised cost estimate and financial assurance mechanism in accordance with 10 CFR 40.36, for the preferred decommissioning approach.
- B. If the Leachate Collection and Treatment System is ever operated, MDNR shall request approval, by license amendment request, prior to operation.
- C. The Radiation Safety Officer for this license is Denise Gruben.
- D. For equipment and materials release, MDNR shall use decontamination limits in "Guidelines for Decommission of Facilities and Equipment Prior to Release for Unrestricted Use or Termination of Licenses for Byproduct, Source, or Special Nuclear Material," Policy and Guidance Directive 83-23, August 1987.
- E. Except as specifically provided otherwise in this license, MDNR shall conduct its program in accordance with the statements, representations, and procedures contained in the application dated September 5, 1997, as supplemented on July 27, 1998, and March 8, 1999; the Radiation Safety Program, dated August 15, 1997; the ALARA Program, dated August 15, 1997; and the Training Program, dated August 15, 1997. NRC's regulations shall govern unless the statements, representations and procedures in the licensee's application are more restrictive than the

regulations.
