SUBJECT: AMENDMENT NO. 1 TO CERTIFICATE OF COMPLIANCE NO. 1026 FOR THE FUELSOLUTIONS™ SPENT FUEL MANAGEMENT SYSTEM TO ADD MIXED OXIDE, PARTIAL, AND DAMAGED FUEL ASSEMBLIES TO W74 CANISTER

Dear Mr. Quinn:

As requested by your application dated September 29, 1999, as supplemented, enclosed is Certificate of Compliance No. 1026, Amendment No. 1 for the FuelSolutions™ Spent Fuel Management System. This certificate supersedes, in its entirety, CoC No. 1026, dated February 15, 2001. Changes made to the certificate are indicated by vertical lines in the right margin. As stated in the Federal Register (66 FR 12435, 02/27/01), the effective date of this certificate is May 14, 2001. We request that you update and submit four copies of the final safety analysis report to conform to the certificate, as required by 10 CFR 72.248.

Amendment No. 1 to CoC No. 1026 constitutes U.S. Nuclear Regulatory (NRC) approval of the following change to the FuelSolutions™ Spent Fuel Management System:

Addition of (1) mixed oxide fuel (MOX) assemblies, (2) partial MOX and uranium oxide (UO₂) assemblies, and (3) damaged MOX and UO₂ assemblies to TS 2.1, "Fuel to be stored in the FuelSolutions™ W74 canister."

This certificate constitutes the approval and conditions for use of the FuelSolutions™ Spent Fuel Management System for storage of spent nuclear fuel under the general licensing provisions of 10 CFR 72.210. A general license has been granted to all holders of licenses for nuclear power reactors issued under 10 CFR Part 50.
